Foys Bend Project Celebration!

The Conservation Fund and Fish, Wildlife & Parks are holding a party and press conference to celebrate the completion of the Foys Bend Fisheries Conservation Area project in early October. For more information contact Gates Watson at (406) 239-6469.

Foys Bend River Fisheries Conservation Area Management Plan

Fish, Wildlife & Parks will release a draft management plan and environmental assessment for the Foys Bend Fisheries Conservation Area for public comment by the end of September. The Foys Bend Fisheries Conservation Area is a 243-acre property along two miles of the Flathead River. Fish, Wildlife & Parks purchased it in February for fisheries conservation using Bonneville Power Administration funds. The draft management plan and environmental assessment will include recommendations for public access, habitat enhancement, weed management, agricultural land uses, education, and other activities. North Shore Projects Update: Bigfork Fisheries Conservation Area Project

Fish, Wildlife & Parks anticipates closing on the 70-acre Bigfork Fisheries Conservation Area on the north shore of Flathead Lake by end of the September. Bonneville Power Administration mitigation funds are being used to acquire the property for the purpose of fish and wildlife habitat conservation and to help mitigate for impacts caused to resident fish by construction and subsequent habitat loss associated with Hungry Horse Dam. Restoration Projects Update

In August, project partners toured six river and wetland restoration projects along the Flathead River to assess their condition and plan for additional maintenance needs. Partners followed up with landowners to discuss weed management and the completion of an off-stream livestock watering facility. Two new restoration projects are planned for next year.

Funding and Programs

Bonneville Power Administration Funding Update

The joint Confederated, Salish & Kootenai Tribes, Fish, Wildlife & Parks (FWP), and Bonneville Power Administration (BPA) 2007-2009 Hungry Horse fisheries mitigation program resulted in significant conservation of fish habitat in the Flathead Watershed. Projects funded by BPA include the purchase of conservation easements along the Flathead River (the Siderius family properties) and at Weaver and McWenneger Sloughs along the Flathead River, and the acquisition of property at Foys Bend (Ingham's property) and on the North Shore (Miller's property) by FWP. Two additional projects are being completed on the North Shore (Mattson's property) and along the Flathead River (three Louden family farms)

Negotiations with the North Shore Ranch did not come to fruition so far and the BPA funding partners hoped to apply to this project will not be applied to the River to Lake Initiative, as the current agreement with BPA ends September 30th. For the next three years, BPA will fund fisheries mitigation projects in the Swan Valley. For more information contact Joel Tohtz at 751-4570 or jtohtz@mt.gov.

NRCS Conservation Reserve Program for Farmable Wetlands Accepting Applications

The Farmable Wetlands Program is a voluntary program administered by USDA's Farm Service Agency to restore wetlands and associated buffers impacted by farming activities. Landowners receive an upfront payment or rental payments for a 10 to 15 year period based on the weighted average dryland cash rent, as well as a portion of the costs of implementing a conservation practice. Landowners can apply at any time. Applications are evaluated immediately and, if application is approved, funding is immediate. Outreach to Realtors - Wetlands & Riparian Buffers

Following the Realtors Workshop held in January, the Flathead Lakers and Montana Watercourse developed and distributed a follow-up survey to participants. At the workshop, 85 percent of workshop participants responded that they would be willing to share information with their clients. In the follow-up survey, 100 percent of respondents (19.5% of participants) said that they had done so. The survey results indicate that the realtors are sharing materials with their clients.
