Conservation and Restoration

Flathead Lake North Shore property protected



Darrel Worm chose to sell his 189 acres at the north shore to Montana Fish, Wildlife & Parks to conserve its many values.

“My hope for this unique

property has been that it could be preserved for the people of Montana to enjoy and that its historic character could be protected,” he told the Bigfork Eagle. Worm also restored the historic barn, built by the original homesteaders of the property.

This project helps protect Flathead Lake’s water quality and critical wetlands used by tens of thousands of migratory birds in the spring on their long journey from wintering grounds in Mexico to their breeding grounds in Canada.

The property is surrounded by other protected lands,

including state and federal land, and other private land protected by conservation easements. A grant from the Bonneville Power Administration funded the project. To read more about this project on our website [click here](#).

Conservation easement to protect Smith Valley critical lands

Flathead Land Trust was recently awarded two grants, a Small North America Wetlands Conservation Act (NAWCA) grant and a Travelers for Open Lands grant, to purchase a conservation easement on nearly 50 acres around Smith Lake west of Kalispell.



The project will protect bird habitat at this significant wetland complex that is used by tens of thousands of migratory birds that depend on wetlands for nesting and feeding.

Smith Lake is also a popular stop for people coming to observe the ducks, geese, swans, and other migratory waterfowl that arrive in the wetlands scattered throughout the valley’s farm fields and at Flathead Lake's north shore.

Critical Lands – the place to see birds!

Twenty-six people joined bird expert Dan Casey on a birding tour in March to observe migratory waterfowl and other birds that use the Smith Lake and West Valley wetlands during their migratory stops between Canada and Mexico.



Landowner Pete Wade, who is working with the Flathead Land Trust to place 50 acres in a conservation easement around the Smith Lake Waterfowl Production Area, talked about his efforts to help protect the property's excellent soil and wetlands.



Bird enthusiasts were able to enjoy a close view of many birds thanks to several experts joining the tour and sharing their knowledge and spotting scopes.
