West Valley Wetlands Conservation Project

The Flathead Land Trust is completing the much awaited conservation easement to protect the 351-acre farm protecting important West Valley wetlands. Hundreds of Sandhill Cranes stop at



the 45-acre wetland and surrounding farmland to rest and refuel for up to two months during their fall migration.

Montana Fish Wildlife and Parks is conducting an environmental assessment and public review process on the proposed public viewing area. The bird viewing area will allow the public to enjoy an amazing bird spectacle. The U.S. Fish and Wildlife Service is holding public scoping meetings on June 6 at the Red Lion Ridgewater Inn in Polson, and June 7 at the Kalispell Public Library to discuss the development of new management plans for the Bison Range Complex, which includes the Flathead Lake Waterfowl Production Area, Blasdel National Wildlife Refuge (NWR), Lost Trail NWR, the Bison Range, and the Ninepipe and Pablo NWR.
