### Land and Water Conservation

## Three Louden Family Farms Protected

Three new projects add to the network of conservation of critical lands along the Flathead River with the protection of the Louden Family Farms. The Flathead Land Trust helped the extended Louden family place three conservation easements on 540 acres of farmland, wetlands, riparian habitat and floodplain. The conservation easements will help the Loudens maintain their property to pass on to their children while protecting some of the best farming soils in the Flathead, as well as water quality, and fish and wildlife habitat.

The properties stretch along the Flathead River to the east and west of Church Slough, and add to an existing

network, now totaling about 7,000 acres of private and public conservation lands along the river. A Natural Resource Conservation Service Farm and Ranch Protection (FRPP) grant and Bonneville Power Administration (BPA) mitigation funding helped purchase the conservation easements. The Flathead Land Trust and Louden family members are now moving ahead with negotiations to place conservation easements on three additional properties along the Flathead River by the end of the year.

#### Bigfork Fisheries Conservation Area Project Completed

Fish, Wildlife & Parks closed on what is now the 70-acre Bigfork Fisheries Conservation Area on the north shore of Flathead Lake. The landowners were interested in selling the property to FWP, which purchased it using BPA mitigation funds. This property borders the Flathead Lake Waterfowl Production Area (WPA). While some public access will be available, FWP plans to manage the property to complement the WPA's fish and wildlife habitat conservation goals.
