Celebrating 10 Years of Success Protecting Critical Lands

The Flathead Lakers initiated the Critical Lands Project in 2000 to address concerns that rapid growth and development could damage lands and waters critical to maintaining the quality of Flathead Lake. A diverse group of people, came together to collaborate on conservation, restoration and education projects.

Critical Lands Project partners decided to first focus efforts in the Flathead River corridor from Columbia Falls to Flathead Lake, including the lake's north shore. This partnership and project is the *River to Lake Initiative*. Priorities for protection include wetlands, riparian forests, floodplains and associated uplands.

River to Lake Project accomplishments are numerous, but most telling is the more than 5,000 acres of critical lands protected through voluntary

New Montana Stream Mitigation Procedure Report released

The US Army Corps of Engineers released new a Montana Stream Mitigation Procedure report. The report provides the Corps' procedures for calculating debits and credits associated with compensatory stream mitigation in Montana. Effects of Urbanization on Stream Ecosystems now available

A USGS study examines how stream ecosystems respond to urban development. Specifically, the report examines the effect of urban development on biological communities, hydrology, habitat, and stream chemistry throughout the United States. Key findings include:

- streams are significantly affected by urban development
- even small levels of urban development had an immediate negative effect on macroinvertebrates
- changes to the biota in streams depends on the region of the country due to differences in climate, geology, natural vegetation, and historical land use patterns, more so than on the level of urban development.
