Conservation and Restoration

Another beautiful river property protected

Diamond B Ranch owners Jerry and Aileen Brosten closed on a conservation easement in December that will

protect their beautiful 192-acre property along 1½ miles of the Flathead River.

Located east of Church Slough, the Diamond B Ranch provides a beautiful



spot along the river for wedding celebrations. River to Lake Initiative partners appreciate the long-term commitment the Brosten family has made to the Flathead Valley – a gift of conservation that protects valuable farm land and builds on the network of conservation stewardship along the river.

Diamond B Ranch includes seasonal wetlands and sensitive riparian areas, providing natural habitat for native plants, fish, and wildlife, including native bull trout and westslope cutthroat trout.

The conservation easement was completed with the assistance of the Flathead Land Trust, which holds the easement, and Montana Fish, Wildlife & Parks, which helped secure funding and is helping the landowners improve the river corridor for native fish. Funding for the project included grants from the Natural Resources Conservation Service Farm and Ranchland Protection Program and the Bonneville Power Administration.

Important farmland and wetlands protected in Creston

Jack and Judy Moses donated a conservation easement on their property, 121 acres in the agriculturally important Creston area. The easement protects prime agricultural soils, scenic views from



Hwy 35, and an incredible range of wildlife habitat — forested areas, open meadows and wetlands, including a plant community listed as "Imperiled" by the Montana Natural Heritage Program that contains Engelmann spruce and skunk cabbage. While this conservation project is outside the River to Lake Initiative focus area, it is another gem in the Flathead landscape, protecting some of the most important farming soils in the state and adding protection to a significant wildlife corridor between the valley and the river.

Stream Bank Restoration Projects

Restoration moved ahead smoothly last summer, including two projects on the Flathead River east of Church Slough, funded by Natural Resources Conservation Service (NRCS) Environmental Quality Improvement Program (EQIP) and Bonneville Power Administration grants. Fencing on one project near Church Slough was so successful in preventing deer from browsing that native plants are regenerating without the need for planting. Montana Fish, Wildlife & Parks is monitoring this project to ensure its success.


