Flathead Land Trust receives Wildlife Conservation Award

NAWCA grants help the Initiative compensate landowners for placing a conservation easement on critical wetlands and bird habitat. This is the fourth NAWCA grant awarded to fund River to Lake Initiative projects. More information about this project will be provided when the project is completed.
